The Hunger Project New Zealand respects, and is committed to protecting your privacy. All information provided to us will remain confidential and protected. It will be used only as outlined below.

The Hunger Project New Zealand complies with the New Zealand Privacy Act 1993 (the Act) and all other laws which protect your privacy.

## PERSONAL INFORMATION COLLECTED

The Hunger Project New Zealand typically asks you for the following information:

- Contact Information (including name, address, email address and phone number)
- Payment Details (including credit card numbers and/or bank account details)
- Personal and Security Details (such as date of birth)

We only collect personal information that you provide directly and it is your choice how much information you provide. All information is held securely.

## USE AND DISCLOSURE OF PERSONAL INFORMATION

We may use the information we collect about you for the purposes of:

- Processing investments and providing receipts
- Maintaining an accurate record of our investors' history with the organisation
- Providing information about The Hunger Project New Zealand's work and activities
- Asking you for support, both financial and non-financial

The Hunger Project New Zealand will never disclose or alter any information from your record unless requested by you. If you wish to allow another person to access your details you need to notify The Hunger Project New Zealand in writing and we will note this on your record.
